- 3) Different planning and execution
  - In the world of management there is a saying that a good plan means 50% of the goals have been achieved. Therefore, in developing discipline, the principal together with the discipline team should design a discipline program properly. Then, a good plan is tried to be implemented well too. Meaning, what has been planned, as far as possible is carried out according to the original plan. If then there is a change, it should be done through an evaluation process first.
- 4) Students are not deterred
  - When strict and consistent school discipline is implemented, there are bound to be students who are violated. Those who violate discipline must be held accountable by accepting school disciplinary sanctions. However, sometimes or often it happens that it is the same person who violates school discipline over and over again.
- 5) People ask for dispensation
  - Our hope is that parents at home help in fostering students and in building student discipline. If there are students who violate school rules, sanctions are given according to the rules. We hope that in this case parents support. The policies taken by the school are supported by parents. But it still happens, even though students and their parents have agreed to the school rules that have been conveyed.

The plan prepared by the school to improve student discipline is the application of rules in which points are included, each child in one semester is given credit points with a maximum weight of 100 points for violations. If the points are still few then they will be given direction, but if the points are many it can lead to the provision of educational sanctions that have been implemented.

## Teacher's Strategy in Improving Student Discipline at Madrasah Aliyah Negeri for Scholarly Persons, Central Bengkulu Regency

Regarding the determination of discipline as a guide in improving student discipline, Payne stated in Mulyasa that "To discipline students it is necessary to have an integrated discipline strategy (assertive discipline), teachers must control, develop and maintain school rules and regulations. The teacher sets the goals to be achieved before choosing the strategy to be used in the program to improve student discipline so that the strategy to be chosen is directed towards achieving it. these goals are in line with the vision and mission of the Madrasah Aliyah Negeri for Insan Scholar, Central Bengkulu Regency in its implementation the forms of discipline applied

- 1. discipline, which includes time discipline, uniforms that are in accordance with school regulations, behave, say, have ethics.
- 2. learning discipline in which students are required to complete the tasks given by the teacher in accordance with the specified time period, follow the lesson well, are ready to learn when in class where preparations are made from home.
- 3. the implementation of disciplinary activities which include morning apples, administration according to the rules, reading the Qur'an, studying, where these activities are carried out simultaneously every day.
- 4. the method used by the teacher in improving discipline with the teacher providing understanding to students about the importance of disciplinary behavior, the teacher providing an example for students to make discipline a habit, the teacher also giving motivation in the form of advice to students to make discipline a habit.
- 5. Supervision in the discipline program that is fully responsible for the rules is the scheduled picket teacher, in addition, students and class teachers participate in accompanying, and indirectly other educators participate in disciplinary supervision of students. Supervision can be controlled through the teacher's picket book, student's personal book, and direct student behavior.
- 6. The teacher gives rewards in the form of praise to students who are disciplined, the goal is that students are more enthusiastic to continue to improve discipline. There are also sanctions or consequences that students receive when they do not discipline, these consequences have been explained in detail according to the form of the violation that has been regulated in the student discipline. When the teacher is unable to handle it, it is necessary to have a family discussion with the parents/guardians of the students.

The teacher's strategy in improving student discipline is

- 1. Give an example or role model
- Discipline learning cannot be done by ordering or punishing students. Teachers must be able to be role models and also examples in behaving in a disciplined manner. For example, the teacher wants the students to be on time. The first thing the teacher should do is to show students that the teacher is always on time and not late unless there is something very urgent. How students will have a disciplined attitude if they see the teacher is not disciplined.
- 2. Making rules or regulations
  - Improving student discipline at school can be done by making a list of clear and firm rules or regulations. Do not let the rules that are made have a double meaning so that students experience confusion because the rules made are not easy to follow or create opportunities for students to commit violations

3. Consistent

Consistency is one of the important keys in shaping the character of students' discipline. Because all teachers provide the same example continuously and then always provide knowledge and understanding to students about the importance of learning discipline to be able to achieve optimal results and also discipline to obey the regulations carried out in the community. Through constant guidance and example, the formation of student discipline character can be carried out optimally.

4. Assertive

Firmness does not mean fierce, angry, then giving punishment to students. Often punishments given under the pretext of enforcing discipline do not produce the desired results. Students who often get punished tend to repeat the same mistakes again and again. In addition, punishment that cannot but make students aware of their actions, on the contrary, will arouse hatred towards the teacher. Firm means not wishy-washy. It is used as the basis for taking action so that students do not take inappropriate actions many times.

5. Collaborate with parents

Good behavior such as discipline is not only the responsibility of the school. Parents as teacher partners also have a big role in instilling discipline in students. It is better for teachers not only to socialize academic targets, but also to inform parents of the attitude targets that they want to build so that there is harmony between what is taught at school and also at home.
