On the basis of the Ministry of Neighborhood and Family Support and its regional divisions, the Ministry of Neighborhood and Religious Support and its regional divisions will be established. A total of 900,000 women who are part of the "Women's Registry" system have received socioeconomic, medical, legal, and psychological support since the system's inauguration in 2020. In recent years, practical measures in the areas of psychological, medical, and mental rehabilitation provided to them have been strengthened in light of the problems with families that are dissolving as a result of family conflicts and situations in our nation and the fact that more women suffer from this.
