Economic culture - its essence, meaning is that people understand the unity of their economic knowledge, beliefs, and practical activities. In this, a person enters into this process with his economic consciousness, activity, attitude. Economic etiquette is a set of consistent moral and ethical behavior of a person in the course of economic activity. First, let's pay attention to the meaning of the words economy and culture. As for the explanation of the word economy, it is derived from the Greek word "economy" (oikonomía), which means proper household management. Economy is economic work, as well as a set of social relations formed in the system of production, distribution, exchange and consumption. The word culture comes from the Arabic word "Madina" (city). Arabs divide people's lives into two types: one is Bedouin or desert life; the second is called cultural life[2]. Bedouin is used for the nomadic peoples living in the steppe deserts, and culture is used for the peoples who live in the city and have their own way of life. There are about 300 terms and interpretations of culture in the sources of world history, and the basis of all of them is the product of human thinking. When both are embodied, that is, the high economic culture of people who can properly approach market relations in the economy is understood.

The formation of economically important qualities of a person is a necessary condition for the successful functioning of the economy of society. Likhachev are mainly of economic importance, such as honesty; so It is based on human moral norms, such as reliability, discipline, accuracy, initiative, commitment, courtesy, respect for the employee, partner, and consumer[3]. The condition of an individual's adequate adaptation to the market type of economic relations is the formation of a complex of knowledge, skills, skills and personal characteristics, which are combined with the concept of economic culture and implemented by the individual in the course of economic activity.

Of course, this definition is very different from the classic definitions known to us from economics textbooks [5]. However, it correctly and clearly reflects the essence of the concept, the complex mechanism of economic relations is closely related to the qualities of the economic and cultural personality, such as "strength of character, the ability to make independent decisions and, finally, a sense of self-worth." reveals its existence.
