On June 19, 2018, the President of the Republic of Uzbekistan signed a decree "On public maintaining order, crime prevention and crime additional measures to increase the effectiveness of the fight In accordance with the Resolution of the President of the Republic of Uzbekistan "On Ensuring Public Order, Crime Prevention and Crime in Tashkent from July 1, 2018" Experiment with the concept of "Safe Capital" based on the system of combat and then this practice at the end of 2018 it is planned to introduce it throughout the country [5]. Of course, this is one of the key issues in implementing this concept is to ensure public safety. This system is currently in practice introduced and implemented by the Interior Ministry and the National Guard divisions are working effectively in mutual cooperation.

Today, peace and stability in all regions of our country and significant indicators of security, crime and the number of offenses decreased sharply. The result is several indicators Uzbekistan is one of the leading countries in the world in terms of tourism and investment attractiveness, the absence of the threat of terrorism and extremism ranked high. In particular, according to the World Solo Travel Safety Report 2019, Uzbekistan ranks 5th in safest countries for lone tourists took place. The safest country to travel to was Singapore. Also Along with Uzbekistan, Iceland, Norway and Entered Finland.

According to the report, among the population of 142 states on several claims survey was conducted. The questions are when they wander alone in the city at night feel safe, trust local police officers and were about to face theft or aggression. It also declares the safest countries to travel to Venezuela, Afghanistan and South Sudan lead the list to be continued.

Also, according to the Global Terrorism Index 2019 report, terrorism Uzbekistan ranks 135th in terms of risk had a score of 0,019. Afghanistan, Iraq, Nigeria, Syria and Pakistan are in the top 5 in terms of the high risk of terrorism. Five countries that do not pose a threat of terrorism are Belarus, Guinea-Bissau, Oman, Gambia, and the Democratic People's Republic of Korea; arrested for ensuring public safety in our country.

Another important achievement is the work of President Shavkat Mirziyoyev April 15, 2021 "In the field of public safety Measures to further improve the system of professional training. This is the adoption of the Resolution "On measures" The purpose of the decision is peace and tranquility of our country prevention of any threats and crime advanced system of training highly qualified specialists in the field of wrestling improvement based on international standards as well as modern requirements law enforcement and the Armed Forces capacity building [7].
