The socializing mechanism helps language users to be conscious that every culture has something to say and those words connote explicitly that they can't be used in a courteous manner. It causes shame and humiliation to the members of the group if they say or do taboo words that seriously clash with the social value. Inconvenience appears to be related to and effects of sexual activity. Different substances, such as physical and characteristic manifestations of perversion, are known for violence. More specifically. (Freitas,2008) The prohibition or evasion of any culture of conduct that would harm its members because of their fear, humiliation or shame.

They are extremely respectful limitations. Therefore, as far as language is concerned, certain things or things cannot be said that can be indicated only under certain conditions. (Wahyudi,2008) That the use of forbidden terms leads to a confusion between the two individuals who have a different knowledge since they are from different cultures and circumstances. Some terms and phrases are certainly tabooed by people, especially when these words and phrases are used as individuals by another social class. The use of taboo words such as n \*gg\*r is an example. If white people use it, Term N\*gg\*r can be highly offensive. It can be openly used without being insulted by any classes of blacks. The parameter of those terms or phrases that are considered to be tabu typically depends on the value of a group, the relationship between the speaker and the hearer, and on how the word is spoken. Since the words prohibited by various cultures are expressed in different ways, they are necessary to enter such taboo words in a single culture.

### **KINDS OF TABOO WORDS**

There are four types of taboo words, namely adjectives, profanity, vulgarity and obscenity.

#### 1- Attributes

The adjective is marked by a variety of slurs, such as slut and the bad. Other adjective-related references such as n\* gg\*r, m\*dg\*t, r\*t\*rd, materf\*ker, t\*t-man, and epithets include: ethnicity, race, sex, sex, looks and disabilities; but they also include a quick but blast. #### 2- Bad language

#### THE TERMINOLOGY TABOO

Taboo terminology was used first when it was sent to Tahiti in the late 18th century. Taboo or generally referred to as Taboo is a Tongan term referred to as dangerous person, thing or behavior, which should be avoided. An example of this can be found in South African Nguni cultures. #### **DISCUSSION**

(Allan2006) Vulgarity has been assumed to demonstrate the coarse street language expression. Therefore, language is typically widely used to humiliate or drop the subject. This species is as profane as it is in second place. The following conversation offers an indication of vulgarity. The word "sex' is known as a surname because it is one of many slurs. The word "B" means a females dog but, when used as a word to offend a human, has a different significance. It could mean she's a prostitute who likes to change his sex partner if it's aimed at a woman. The word means a homosexual who plays the part of a female in sexual intercourse if guided to a man.

### **Functions of Taboo Terms**

The roles of banned terms are discussed in this section. Four roles, including self-drawing, provocation and showing disrespect and illusory authority, are shown in the prohibited terms.

## A. To show contempt

In order to demonstrate disrespect this feature, people will utter prohibited words to show disrespect for the recipient. The speaker can be said to insult his counter ego, since his other partners believe they are absolutely useless.

### B. To attract attention to oneself

This role takes place when a person utters a prohibited word that has a strong connotation in order to attract the attention of the listener. In addition, listeners can automatically react to the speaker using strong and durable language files such as Forbidden Word.

### C. Be provocative

The third position is a provocative feature when the speaker speaks forbidden words that give the listener clear answers, such as breaches or frustration. It is considered the most successful way to cause a messy response to applying banned words to somebody's voice. Therefore, in their conversations some people prefer to use forbidden words to get the listener's expected response.

## D. For fake strength

Mockery is less hesitant about the role of the authority than other occupations of prohibited terms. This can happen when people say forbidden words because public images such as government and organizations are not pleased with them. (English, 2008). They therefore use taboos to prove that they disbelieve in government materials, which is the ridicule of authority. The forms and purposes of banned terms are closely associated. It could contain all or some functions for any forbidden word type. In some types of works, some blocked text functions can appear more or less. As the highest frequency, for example, obscenity should appear.

Outrage is the job. (Freitas,2008) The most received work in the vulgar genre is often to display contempt. However, the role of disrespect does not only occur in the participle form once, whereas profanity does not appear. The coarse and vulgar styles are sometimes expected to display disdain as a work. When speakers wish to offend or disrespect others, they use obscene and vulgarity, as it is often considered more successful to cruelly and dirtyly harm the pride of others. To express disdain though, the vocabulary of vulgar language is not as moderate as it hurts others; don't say it if you want to show disrespect towards others. They cannot prove that their real aim is to make others look worthless.

# **CONCLUSIONS**

Any results may be as follows on the basis of the observations and discussions.

- 1. This research aims primarily at identifying and describing organisms The frequency of terms that are forbidden and all four kinds of words that are banned consist of pornographic, profane, vulgar and a superior title is black. Darkness is the most commonly used tabu term, as it's also the best way of offending anyone. In addition, characters also use this lewd genre to show the person they disrespect. The speaker can easily define the pride of others by using obscenity that includes contempt in its significance, repugnance, indecency and intolerance, and his purpose to injure others' feelings. The adjective is the least used prohibited term. Thus, this characteristic cannot be used as an inflammatory word to destroy other people's pride. It can be observed. Instead of using adjectives as a language of offense, use the adjective as an adjective to draw attention by name and some sort of slander such as the word denoting sexual activity.
- **2.** The second aim of this study is to define the functions of taboo terms. The series comprises four functions: show disdain, draw attention to oneself, provocation, and authority cynisms. To be disdainful. One duty is to make fun of authority. It can reflect the intention of the speaker to use these prohibited words to display contempt towards others. It can also convey a feeling of disrespect to someone the most successful function, as it is targeted and aimed at harming the pride of others.

For taboo word forms, obscenity is the highest repetition rate. Obscenity is a common word taboo since it is seen as the perfect way to offend someone. In addition, the form of obscenity is also used to indicate contempt for the sender. The voice can easily degrade other people's pride and damage their intent by using the darkness that contains the disgust of the mind, is repulsive, indecent, and has no morals. Obscene, which is gross, repugnant, indecent, and moralizing, can easily achieve the feeling of others. A speaker can easily characterize others as "stoler, and their aim is to hurt others" Cursing is the least popular term. It can therefore be seen that profanity is not powerful enough to be used as a word that offends others' pride, as it is often classified as stalking religions which incorporate the obscene use of what is deemed sacred.

Taboo words are often unacceptable and cannot be used as conversations on a regular basis. Banned terms in the majority of languages are therefore still offensive and brutal, but today it seems that the attitude towards Taboo feature has already changed words. The changes were due to the absence of legal prohibitions. In certain cultures, the pattern is now that people tolerate banned terms more easily. The purpose of this study is to define the types of words prohibited and to examine the words prohibited in words and to use the theory of the types of words prohibited. Since data analytical obscenity is considered the most successful way to attack anyone, it is the most common form seen in this research. Obscene language is the least used forbidden term. Therefore, the use of profanity as a derogatory word to degrade the pride of others is not successful enough, since it is generally known as stalking religions, and comprises the indecent use of what exists.
