One of the most pressing and socially important tasks facing our society is to find ways to reduce the number of offenses among these minors and increase the effectiveness of their socio-psychological adaptation.

The need to address this problem as soon as possible is due to the fact that the more ambiguous criminogenic situation in the country remains, but primarily the involvement of minors in crime.

The creation of normal social and pedagogical conditions for the legal development and upbringing of minors is the most important direction of their protection from the effects of crime. In addition to the humanitarian and philosophical aspects of this problem, it is also important to have an example of the offenses committed.

Of course, juvenile delinquency is dangerous for society because it threatens the future of young people. Social attitudes, bad habits that emerge from a young age lead to a deep moral depravity of the individual and as a result lead to an increase in crime and delinquency.

The main purpose of legal education of young people is to form their legal consciousness and on this basis to create active legal behavior.

According to N. Kasimova, the "level of legal awareness" is not only the awareness of young people about the rights, knowledge of the law, but, above all, the willingness to obey and obey the law, obedience to the law, respect for law and justice¹.

It is necessary to study the basic provisions of the law and to form respect for it. The knowledge gained must be transformed into a personal trust, an impeccable attitude to the strict observance of the requirements of the law, and then - an internal confidence to comply with the norms of the law. The problem of the "legal minimum", i.e. the level of study of the laws that everyone should know for the benefit of our society, regardless of their social status, plays an important role.

Unfortunately, the level of this work does not apply to the current level of modern development of the youth community. Government agencies that need to solve this problem are not separate or they work separately.

In his speech at the 72nd session of the UN General Assembly, President of the Republic of Uzbekistan Shavkat Mirziyoyev spoke about the role of youth in our society, saying: "It is necessary to develop multilateral cooperation in social support of the younger generation, protection of their rights and interests. In this regard, in the current context of globalization and rapid development of information and communication technologies, Uzbekistan proposes to develop a generalized international legal instrument for the formation and implementation of youth policy - the UN International Convention on the Rights of the Child. In our view, the signatories of this document must make a firm commitment to raise this area to one of the main and important vital priorities of their social policy. In this regard, the most important task is to form and educate the minds of people, especially young people, on the basis of enlightenment²".

The concept of 'legal education' is very closely related to the concept of 'legal enlightenment'. Legal enlightenment is a systematic activity of the state and the population aimed at a specific goal, to resist legal doubts and ensure the formation of the individual in the spiritual sphere, the formation and strengthening of legal consciousness and legal culture in the implementation of legal ideas.

In this regard, it is important to ensure the full and quality implementation of the decision of the Cabinet of Ministers of December 14, 2020, which approved the National Program for the Development and Support of Reading Culture for 2020-2025.

At the same time, upbringing in the spirit of respect for the law and the law is not limited to legal education, the creation of a positive attitude towards them, but also consists of the legal activity of this person, the legal culture.

The first concepts of the formation of legal culture are acquired by children in the family, in preschool education, and in school, they acquire knowledge about state building and the constitutional system, the rights and freedoms, obligations of citizens.

Legal education is interrelated with the legal education of young people. Legal education is the process of forming the consciousness of a person subject to the law, including the continuous connection of legal relations. Law and legal liability cases should be of high quality and developed in a timely manner, and this should not be temporary blindness. Due to the fact that legal education has an organized, systematic and purposeful impact on the development of legal consciousness, it is necessary to pay attention to intellectual, moral and aesthetic, as well as legal development in connection with the development of legal consciousness, attitudes, skills and active legal behavior.

The lack of this direction in the ongoing educational work has a negative impact on the legal mind of young people. During the implementation of the crime prevention process among young people, socio-psychological events should be taken into attention. The media is one of the leading areas of legal advocacy as a form of legal advocacy.

The uniqueness is that this process, due to its mass nature and general existence, involves many people and therefore becomes an integral part of public consciousness, which in turn influences the formation of certain legal ideas and preferences of people. According to a survey of students, the most popular sources of information in the legal field for them are television, the Internet, as well as family conversations.

In order to form an interconnected system of legal education and youth in our country, including government agencies, the media and public associations, it is necessary to:

- creation of conditions for the development and implementation of special curricula in all educational institutions (schools, secondary special and higher education institutions);
- organization of the introduction of compulsory legal disciplines in all educational institutions from primary school to higher education;
- increase the number of publications on the protection of our youth from the processes of international globalization;

- Improving the quality of education in the formation of legal culture of young people.

Thus, a well-developed and effective system of measures and legal advocacy will increase the level of legal culture of young people, improve the quality of legal awareness of the population and reduce the behavior of a stable person who deviates from social norms.
